OPERATIONS & MAINTENANCE PROGRAMS:

Effective Operations and Maintenance (O&M) is one of the most cost-effective methods for ensuring reliability, safety, and energy efficiency. Improvements to facility maintenance programs can often be accomplished immediately and at a relatively low cost. There are various operations and maintenance programs and policies that employers can implement on Air Quality Action Days, for the entire Ozone Season or throughout the year.

- Use low emission or alternatively fueled vehicles
- Improve facility energy efficiency
- Delay or reschedule lawn maintenance & landscaping activities after 6pm on Air Quality Alert Days.
- Reschedule the use of construction equipment & small diesel generators or boilers for evenings or avoid on Air Quality Alert Days
- Purchase Energy Star certified equipment, programmable thermostats and energy-efficient lighting
- Ask employees to turn off lights, computers, printers and other office equipment when not in use
